IN MEMORIAM

Within the last six months, Susan McLain and Ed Burgess' passionate voices, that reflected the spirit and mission of ACDFA with dignity and integrity, were quieted.



Ed Burgess was chair of the dance program at the University of Wisconsin-Milwaukee, and is believed to have peacefully passed away in his sleep. He had recently taken over the position of Regional Director for the North-Central Region, after having served on the ACDFA Board of Directors since 2008. Ed's energy was undeniable and his contributions to ACDFA and our art form resonate deeply within the people who surrounded him. His rich career and indefatigable enthusiasm for education made him a deeply admired teacher, friend, and artist. Never without a smile, Ed's thoughtful approach to life served as a cornerstone for many young minds, leaving them a legacy of kindness and generosity.



Susan McLain, dancer, choreographer and faculty member at the University of California–Long Beach for 18 years, passed away on August 5^{th.}
Susan, who energetically served ACDFA for 11 years as a board member, Southwest Regional Director and subsequently the Vice President for Nominations and Elections; was a driving force in creating a solution to what had been an enduring overpopulation problem for the Southwest region. Her tireless efforts have changed ACDFA permanently. To many, she was a voice of fairness, caring, and unadulterated joy. Susan was an advocate of dance that celebrates a vibrant future, with a sense of reverence for its past.

ACDFA honors these incredible artists. Their influence on and contributions to ACDFA are considerable and as the organizations lives on, so will a part of them.

Registering for a Conference 101:

The Basics

By now, your region's host has an open website for you to peruse. There you will find the information you need to begin planning for your trip to the conference, and the deadlines that will be here before you know it. Here are some things to keep in mind:

- Register as early as you can.
- Only register for the number of participants that you are firmly committed to bringing.
- If your conference host is doing in-region priority, registration for YOUR region will open on October 3rd, 2011.
 - *Registrants will be required to input an invitation code to gain access to the registration pages. Conference hosts will email the invitation code to current institutional members during the last week of September.
- *Registration for ALL conferences will open **October 17th, 2011**.
- *By now, we are all aware that conferences fill up rather quickly and your registration is not complete until payment is received by the host.
- * There are NO REFUNDS on registration fees!

In order to help your host run the most efficient, seamless, and exciting conference possible, please pay particular attention to the deadlines listed on the website for your region. It is critical that all schools submit program information, technical information, class descriptions, teacher bios, etc. in a timely manner. Any additional questions you have may be directed to your Conference Coordinator, or Regional Director.

What if my institutional membership has not yet been renewed?

If your ACDFA Institutional Membership is still in the process of being renewed, you should register as a member school starting either October 3rd or October 17th. Do not wait until your membership check has been processed in the national office.

The North-Central region will be coordinated by Li Chiao-Ping, and hosted at The University of Wisconsin-Madison, March 28-April 1, 2012.


The Northeast Region will be coordinated by Michele Dunleavy and hosted at Penn State University, March 2-5, 2012.

ACDFA's Pride and Joy:
Conferences Galore in 2011— The Cliffs Notes Version!

No one will be surprised to hear that last year, ACDFA hosted 10 incredible conferences. After all, that is what we do best! The year brought new innovation, new designs, and new energy to the tried and true gatherings we enjoy each spring. Following is a quick review of the tremendous work being done all over the country.

Central Region



Nick Johnson, Renee Goforth, and Sabrina Vasquez from the Wichita State University hosted 530 participants, Andrew Palermo, Melissa Lowe, Loretta Livingston as adjudicators, and Mary-Jean Cowell, the Central Region's Regional Director. Together they brought 48 dances, five adjudication concerts, 25 informal dances, and a Gala concert to the dance hungry students. The theme of "Come Fly with Us" permeated the conference, including the final reception in an airplane hanger with a real plane. The Central Region is beautifully poised with hosts for the next four years!

East- Central Region



The University of Akron was the home for the East-Central Conference, under the direction of Neil Sapienza. They boasted a dynamic adjudication panel of Victoria Marks, Igal Perry, Camille Brown, and Regional Direction by Balinda Craig-Quijada. This conference accommodated 29 schools, 456 participants, and 58 dances both adjudicated and informal. Classes ranged from Caribbean Groove, to Floor Barre, Embodying Paradox. The folks at the University of.Akron.epitomize gracious hosting and impeccable organization. This region has hosts projected through 2016!

Mid-Atlantic Region



Lauren Kearns, future Mid-Atlantic Regional Director, from Elon University stepped up to the plate and opened Elon's doors to the Mid-Atlantic Region. The 430 attendees were treated to a performance by Lehrer Dance Company, multiple receptions, 41 adjudicated dances, 13 informal pieces, and the wisdom of adjudicators Claire Porter, David Parker, and Gabri Christa. Elizabeth Lowe Ahearn was the Regional Director in attendance. This conference brought extra attention to its carbon footprint by using all local vendors, among other practices. Mid-Atlantic schools are enjoying the luxury of confirmed and projected host schools for three years.

North Central Region



Snowy Minnesota welcomed the North Central Region; more specifically, St. Olaf College and former ACDFA Board Member, Heather Klopchin. The late Ed Burgess, acted as Regional Director during the conference. David Dorfman, Nicole Stanton, and Keith Johnson expertly adjudicated 37 dances and offered master classes to the 469 participants. In addition to 15 informal pieces, receptions, great food, and gorgeous facilities, the conference presented an opening night dance offering from some of the state's finest dance companies. Following suit with ready and willing hosts, the North Central region is secure through 2015.

New England Region



William Seigh, ACDFA's beloved past President, welcomed 407 participants to Keene State College. The **New England Conference** presented a who's who of contemporary dance with an opening concert by Monica Bill Barnes, and a closing concert of work by, Mark Haim, Lisa Race, Edisa Weeks, and David Dorfman, to name a few! There were 40 adjudicated dances, 13 informal pieces, receptions, belly-dance classes, dance for film screenings, and late night contact jams.

New England's hosts are solid through 2015. Terese Freedman, Regional Director, and adjudicators Monica Bill

Barnes, Mark Haim, and

Maura Keefe, were the voices of the conference.

Northeast Region



Muhlenberg College became the Northeast's stomping grounds under the watchful eves of Karen Dearborn, ACDFA Treasurer, Jessica Bien, and Regional Director, Michele Dunleavy. The 513 dancers presented 37 adjudicated pieces, 17 informal pieces, and took part in classes, dinners, receptions, and a concert by Urban Bush Women. The stellar adjudicators were Gabri Christa, Susan Hadley, and James Sutton. Another highlight was the focus on Screen Dance, including adjudication of videos made during the conference by participating schools. The

region only has one confirmed host set for 2012, there are hosts projected

through 2015.

Northwest Region



Gesel Mason and Nicholas Leichter headlined an opening night performance in the Northwest Region, at the University of Idaho. There, conference coordinator Greg Halloran along with Regional Director, Marsha Knight, assembled an expert adjudication panel of Gesel Mason, Nicholas Leichter, and KT Niehof to comment upon 34 dances. There were 17 informal pieces, Men's Dance classes, injury prevention classes, and classes devoted to dance and deaf culture. The eager Northwest proudly positions itself as one of the most secure regions where hosts are concerned. There are projected and confirmed hosts through...wait for it... 2018!

South Central Region



Amidst the saguaro, 528 participants danced in 48 adjudicated works, 26 informal pieces; took capoeira classes, attended receptions; and enjoyed Hilary McDaniel-Douglas' Project in Motion. Debra Knapp, the conference coordinator, brought these events to fruition with the assistance of Regional Director, Susan Douglas Roberts. The adjudication team was Kay Anderson, Patrick Suzeau, and Robin Wilson. Born of necessity, was a day mid-conference without any adjudication. This "down" day was so warmly received that the 2012 host will be scheduling similarly. The South Central Region has a variety of confirmed and projected hosts through 2019.

Southeast Region



The award for the largest conference goes to Florida State University, who hosted 580 participants. Russell Sandifer and Jen Atkins along with the Southeast Regional Director, Angela Gallo, opened their doors, yet again, to another successful event. The impressive adjudication panel included Bebe Miller, Zvi Goetheiner, and Mary Cochran. There were 44 adjudicated dances,

18 informal pieces, and 149 classes offered in their magnificent facility. Highlights of the conference included eight performances by Site-Specific/Installation/ Collaborative Alaskan artist Emily Johnson and a mardigras themed reception high atop the FSU's stadium

Southwest Region



The schools in the Southwest region enjoyed its last conference together before dividing into Baja and West regions for 2012. At California State University, Long Beach 493 participants took part in a meaningful gathering. Coordinated by Andy Vaca, Baja Regional Director, and the now late Susan McLain, the conference offered 40 adjudicated works, 22 informal pieces and several receptions of full meals and well-fed participants. Regional Director Cathy Davalos and adjudicators Frank Chaves, KT Niehof, and Joan Woodbury were on hand to guide the artists in attendance. Registration for this conference closed within eight hours!
