POLICY AND PROCEDURES

Below are the newly approved policies directly affecting <u>ACDA Institutional Members</u> (revised or new language in *italics*)

RE: Minimum requirements for an ACDA Conference

In order to qualify for ACDA sponsorship, Conferences must be scheduled for a minimum of three (3) days with the following required activities: classes and workshops; Adjudication Concerts; Adjudication Feedback Sessions, and a stand-alone Meet the Adjudicators event. In a National Festival year, a Gala Concert comprised of the adjudicators' selections chosen from the Adjudicated Concerts (as per Adjudication Policies for Adjudicators) must also be scheduled.

RE: Registration fees and caps

The President, Executive Director and Treasurer will recommend to the Board of Directors a maximum registration fee amount for all Conferences, including possible increases in this amount as needed... *The recommended registration fee is \$130. The maximum registration fee is \$145.*

RE: Required mobile app use as a trial period policy

For a trial period in 2020, ACDA requires that all conferences and the National College Dance Festival use the event app prescribed by the National Office. Host schools experiencing campus issues that preclude them from utilizing said app must contact the National Office to discuss options.

RE: Promotion of degree and non-degree programs during an ACDA Conference

Promotion of workshops or opportunities outside of a degree program is permitted within ACDA policy and conference guidelines/limitations established by the Conference Coordinator. Faculty, staff and students from participating institutions may not independently initiate recruitment for their own matriculating programs during regional conferences. This includes holding auditions, initiating conversations with potential program candidates, advertising in conference materials, and/or distributing recruiting materials. *Recruiting materials may only be distributed during official informational events sponsored by the Association.*

RE: Permanent policy for musician-performers in Adjudication Concerts, (striking "For a trial period in 2018 and 2019")

A student, faculty member, or guest artist may choreograph a work presented for adjudication in any idiom; however, only students may perform. In addition to student performers, musicians may be visible to the audience whether they are students or non-students.

A sound recording (when applicable) of concert quality to accompany the dance will be provided by the choreographer for the performance in the format specified by the Conference Coordinator or Conference Technical Director. Should the music or sound score be performed live, musicians may be visible to the audience whether they are students or non-students. All performers must be registered for the conference.

RE: Musician-performers

Each musician-performer is required to register as a Conference participant.

RE: Permanent Statement of Empowerment (no change to 2019 wording) All conference registrants are required to sign the Statement of Empowerment that reads as follows: "ACDA recognizes that Art can provoke; therefore, during the course of the conference, participants are empowered to remove themselves from conference activities."

RE: Procedure for voicing perceived violations of ACDA policy and procedures ACDA encourages all members to voice their concerns, complaints, or problems regarding perceived violations of ACDA policy and procedures.


