

Registration Instructions For 2023 National College Dance Festival

Preparing to Submit Detailed Program, Teaching & Additional Information Facilitating Step Two of Festival Registration

Introduction

Note: Cvent will time out after 60 minutes.

If you have a large group, we strongly recommend preparing your answers in advance of reentering your registration.

In addition to basic registrant information, online registration collects details on Gala Concert and informal dances, teaching and research proposals, and additional information for Festival participation. A list of what will be asked in the online registration follows to help prepare information in advance and expedite entering information.

Your cooperation is requested in meeting all posted deadlines for submission of information. Without full information from every school and individual, the Festival Coordinator cannot schedule performance order, tech rehearsals and classes and research presentations. Delayed schedules affect all participants. The importance of honoring all deadlines cannot be overemphasized.

The Faculty Representative (or Board Member serving as Faculty Representative) will enter information for their group.

The Faculty Representative should enter emails addresses for all faculty and musicians in their group.

If any information is not yet known, enter "TBA" and provide information as soon as possible and no later than the posted deadline.

Informal Showing Open to all Festival Registrants

Participation in the Informal Showing is open to all Festival registrants, but space may be limited. Priority will be given to those schools and individuals not performing in the National Festival Gala Concerts. Informal Showing participation is limited to two (2) dances for each school (faculty and students are welcome to perform) and one (1) dance for individuals. Check Festival website for time limitations for Informal Showings dances.

To reserve spot(s), you must select the box on the **Registration for Performance Opportunities & More** page. Check your registration to confirm that a spot has been reserved. It will say "Free."

Program information will be collected outside of Cvent. If participating in the Informal Showing, please provide all program information by the posted deadline. If information is not received, printed programs will read "information not submitted."
